Notes from the Forum meeting 16 May 2013 held from 2-4 pm at St Peters, Harrogate

Ann Hill welcomed the group and it was good to see so many familiar faces regularly attending meetings of the Forum.

Report back from the Annual General Meeting

Ann said the AGM agreed the new constitution which established the Forum. The underpinning principles of the constitution are that older people:

- Have a positive contribution to make to community life;
- Are recognised and valued for their achievements and responsibilities;
- Have a voice and seek to use this to influence the policies and services that affect them.

The newly elected members of the management committee introduced themselves and Ann confirmed that she had been elected Chair at the first management committee meeting.

Health Watch

We were joined by David Ita, Partnership Co-ordinator from Health Watch who gave an informative presentation on Health Watch. He explained that Health Watch are a new consumer champion for the public, patients, health and social care users, carers and their families. If you have a complaint about your GP, Dentist or Care Home you can contact Health Watch to report it and they feedback to commissioners and service providers on your behalf.

North Bank Forum (NBF) have been awarded the contract to support the development of Healthwatch North Yorkshire. Clover Leaf Advocacy Services have been awarded the contract to support individuals through the NHS complaints process and help them to have their concerns heard.

Local Healthwatch will have 3 key functions:

- 1. Influencing helping to shape the planning of health and social care services
- 2. Signposting helping people to access and make choices about their health and social care
- 3. Advisory supporting individuals to make complaints about health care

Local Healthwatch will take evidence built on consumers' views and experience and use it to help shape and improve local services. They will then pass on information and recommendations to Healthwatch England and the Care Quality Commission.

NBF are setting up an Executive Board who will have representation on North Yorkshire Health and Wellbeing Board. They would like to recruit volunteer Health Watchers who will be trained up to gather views of the public, become assessors and provide feedback. Members were invited to fill in a form and sign up if they wished to become Health Watchers.

There will be drop-in's at libraries to inform the public about the service and Harrogate Library will have their drop-in on 6th June.
